2. Roll Call:

President Shrestha called the meeting to order at 12:40 PM PST in person. Following the roll call, it was noted that a quorum was present. Secretary Gyawali started the formal proceedings.

3. Approval of the previous minute:

5. Discussion/Decision(s):

- A. Joint Treasurer Mr. Dilli Thapaliya presented the financial report for the month of October 2025. The total income for the month was \$74,687, while operating expenses were \$13,943 resulting in net savings of \$60,744 for the month. As of October 31, 2025, the total fund balance of SPFU stood at \$1,443,236.
- B. The meeting included a discussion on preparations for upcoming events such as Satabij, International Meditation Day, Giving Tuesday, and Shivaratri. Satabij is an annual event, and we will coordinate with Guru Choodamani to celebrate it accordingly. International Meditation Day will be celebrated on December 21, 2025, the same day as the annual AGM. Details for the remaining events will be discussed in the upcoming meeting.
- C. Nepali Pathasala Principal and SPFU Board Joint Secretary, Mr. Suman Dhakal, provided an update on the ongoing Fall 2025 session. He mentioned that Nepali Pathasala is holding its annual talent show on December 7, 2025, which is expected to be a grand event. He also noted that long-time Nepali Pathasala lead Mr. Shyam Joshi and volunteer Mr. Nakul Thapa will not be available on upcoming Sundays, so preparations for alternative arrangements are needed.



D. Year 2025 Annual AGM Preparation

President Shrestha proposed holding the Annual General Meeting (AGM) on Sunday, December 21, 2025. He expressed his intention to share responsibilities with President-Elect Ram Babu Pandey and Senior Vice President Siddhartha Silwal. He suggested that Mr. Pandey take the lead on the management side and Mr. Silwal oversee event-related activities. President Shrestha emphasized the importance of strengthening responsible management within the organization.

E. Additional Agenda Items

Senior Vice President Silwal proposed organizing weekly yoga sessions every weekend. The Board discussed the idea and agreed that additional time is needed to review the proposal. Further discussion will be carried out in the next meeting.
